HCCMCA AWARDS PPO CONTRACT TO AETNA

Calling it a "good marriage based on a mutual willingness to focus on solutions," Norman Seabrooks, Aetna's president for the Northwest Market, expressed enthusiasm when the HCCMCA selected Aetna to replace Beech Street as its national preferred provider organization (PPO) vendor.

"This contract is

extraordinarily important to Aetna, in Alaska, the Pacific Northwest and nationally. We

see it as an opportunity to make a real difference in improving the quality and affordability of health care, especially in Alaska," he continued. "We also are pleased to offer participating member health plans additional tools for cost containment and member communication." The new contract will be in place by the end of 2013.

"We were impressed by Aetna's ability to help us meet our goals: to help member health plans offer their participants outstanding benefits and high-quality health services at lower costs," said HCCMCA Executive Director Fred Brown. "Total savings are estimated to exceed \$250 million annually, representing more than 26% off the billed charges. We expect member plans west of the Cascades to save more than 5% on average over their prior networks."

Selection Process Focused on Value and Services

Twenty-nine Alaska and Pacific Northwest health plans, representing more than 58,000 employees, and incurring more than \$1.1 billion in health care costs over 12 months, submitted data for the Request for Proposals.

In a selection process Seabrooks described as "rigorous and thorough," the HCCMCA Board looked at the "net discount" (the total discount minus the total fee) for each of the four companies that responded. "Overall, Aetna impressed us with its extensive and growing provider network, additional features and programs and commitment to working with us to deliver quality care at competitive prices," said Brown.

COALITION HEALTH CENTER TO DEBUT IN ANCHORAGE


The HCCMCA now offers a convenient, cost-effective alternative to doctor office visits at the Coalition Health Center in Anchorage, Alaska. Located on the Alaska Regional Hospital campus, the clinic provides primary care, preventive care and chronic condition management.

"We know that people are more likely to seek health care if it's easily accessible. That includes walk-in service and extended hours for people who work weekend, evening or night shifts, as the participants of many Coalition member health plans do," said Fred Brown, HCCMCA's executive director. "Making health care more available and affordable is the bedrock of what the HCCMCA does. Extended hours and a per-visit cost guaranteed by the Coalition that is below the local average for doctor office visits will help us accomplish those goals."

The Services Offered at the Center

The Anchorage clinic, open only to employees and family members who belong to participating HCCMCA member health plans, is a pilot that may be replicated in other locations throughout Alaska and the Pacific Northwest. It:

- Is staffed by fully qualified, lower cost mid-level practitioners
- Offers treatment for common non-work related injuries and acute/episodic illnesses, including symptom relief, diagnostic tests, laboratory services, care coordination, and specialist referrals
- Delivers preventive care services, including wellness visits, physicals, immunizations and lab tests



The 5,000-square-foot Coalition Health Center, located on the Alaska Regional Hospital campus, is scheduled to see its first patients October 16, 2013.

- Offers walk-in treatment for work-related injuries, return-towork assessments, drug and alcohol screenings, physicals and coordinates with workers' compensation providers
- Will dispense select generic and pre-packaged medications
- Provides chronic condition
 management

The Coalition Health Center also will offer a range of health coaching and wellness services, tobacco cessation services and an occupational medicine program. For details, go to hccmca.org and click on Programs, then Coalition Health Center.

A Solid Partner to Manage the Clinic

The Coalition Health Center will be managed by h2u (Health to You), a leading provider of onsite clinic administration services. It is a subsidiary of Hospital Corporation of America and delivers services to more than 400,000 people nationwide.

The clinic will operate without profit, for the benefit of our member health plans. HCCMCA will pool

administrative costs among participating member health plans. The Coalition will pay h2u an administrative fee to operate the clinic and will cover all other costs, including rent, salaries and benefits and supplies.

Currently, costs in the Anchorage area for a primary care visit range from \$150 to well over \$300. By comparison, at the Coalition Health Center – the initial pilot clinic – the cost is expected to range between \$75 and \$100 per visit. And, as the volume (number of covered lives) and utilization (actual visits per covered life) increase, the average cost per visit will decrease.

The first HCCMCA member health plans to participate include ASEA/ AFSCME Local 52 Health Benefits Trust, Public Employees Local 71 Trust Fund and Alaska Laborers Health & Security Fund.

AETNA CHOSEN AS NEW PPO VENDOR THE NEW PPO AGREEMENT IS ESTIMATED TO SAVE MEMBER HEALTH PLANS MORE THAN \$250 MILLION ANNUALLY. SEE PAGE 1!

Since 1994, the Health Care Cost Management Corporation of Alaska, Inc. (HCCMCA) has been helping member health plans control health care costs by negotiating better pricing on health benefits and services than these same plans could achieve on their own. Current member health plans include 23 headquartered in Alaska and 13 headquartered in the Pacific Northwest.

PHARMACY BENEFIT MANAGEMENT IS THE RX FOR HIGH PHARMACY COSTS

Seventeen HCCMCA member health plans know a good thing when they see it (with at least two more coming on board 1/1/2014). They have already signed up for the Pharmacy Benefit Management (PBM) program, thus

gaining early pricing concessions for their covered participants, effective October 1, 2013. Those plans and their participants will benefit from the Coalition's renewed agreement with the not-for-profit, member-owned purchasing coalition, National CooperativeRx. The agreement gives HCCMCA member health plans access to



negotiated large group discounts through the CVS/Caremark chain of pharmacies.

"Prescription drug benefits are among the fastest growing cost areas for health plans. The Coalition's PBM program offers members greater purchasing power,

enhanced customer service, increased transparency and support for navigating PBM issues," said Robin Mullins, Fairbanks North Star Borough School District and HCCMCA representative on the National CooperativeRx board. "Instead of being a 'little fish in a big PBM pond,' we're swimming with the bigger fish." In 2012, more than 2 million prescriptions were filled through HCCMCA's PBM, and National CooperativeRx paid out more than \$2.5 million in rebates to HCCMCA member health plans.

But the benefits go beyond cost savings. The PBM program promotes long-term wellness through customizable clinical programs. Online tools and a mailorder pharmacy make it easier for people to comply with doctors' orders, especially when it comes to managing chronic conditions.
