COALITION HEALTH CENTER PUTS SERVICE ON CENTER STAGE

he Coalition is all about member service and satisfaction, so when we have an opportunity to improve on either of those, we jump on it. That is the motivation behind a few changes at the Coalition Health Center (CHC).

"When we opened the CHC last year, we knew the first few months would be a time to watch how things went and identify areas for improvement," said Fred Brown, HCCMCA executive director. "We appreciate your patience while the CHC transitions to new management. In July, Beacon, an Alaska-based health care company took over the CHC. Having a more local management team will allow us to be more responsive, while still offering the same wide range of services and high standard of care."

The opening of a second CHC in Fairbanks is another way the HCCMCA is working to meet member needs, according to Brown. (See story, p. 3)

Both Coalition Health Center locations are open exclusively to members of participating HCCMCA health plans. For those plan participants, the CHC is:

Convenient: Appointments, callahead and walk-ins are all welcome. The CHC can handle urgent care, primary care and preventive care needs. Appointments should be made for routine and preventive care services. Affordable: There is no cost to your plan participants when they receive health care at the CHC. They do not have to make a copay or meet the annual deductible.

Accessible: The Anchorage CHC is centrally located on the Alaska Regional Hospital campus with plenty of free parking. The Fairbanks CHC also will be in a convenient location with parking. (*See story*, p. 3)

Both CHCs are staffed by professional health care providers fully qualified nurse practitioners and physician assistants—who provide:

- Cost-saving prescription benefit management gives HCCMCA member plans volume discounts and significant savings on prescription drugs from CVS Caremark. National CooperativeRx provides independent program oversight including audits, contract negotiation and objective clinical and pharmacy benefit expertise.

Your plan participants can get flu shots and low-cost health tests, including blood screening, prostate-specific antigen testing, thyroid testing and other preventive care services.

- Coalition Health Centers on the Alaska Regional Hospital campus and soon to open in Fairbanks, offer extended hours, convenience, a range of care options and office visit costs—guaranteed by the Coalition—below the local average.

Coalition Health Center Coming to Fairbanks

One of the biggest assets HCCMCA offers its members is strength in numbers. The opening of the Fairbanks Coalition Health Center (CHC) doubles the opportunities for members of participating plans to save both time and money when they need primary, preventive or urgent care.

Targeted to open late in 2016, the Fairbanks CHC is located in the Ridgeview Business Park, near the Parks Highway and Geist Road intersection. Like the Anchorage CHC, it will be managed by Beacon, an Alaska-based health care company.

The Center will feature six exam rooms equipped for X-rays and minor procedures. Services will include primary care (cough, cold, sore throat, ear ache, cuts, fever, rash, immunizations and physicals), urgent care, as well as chronic and acute illness prevention and management. There will be an onsite pharmacy, laboratory and EKG equipment. As in Anchorage, the Fairbanks site will be staffed by skilled, trained providers and nurses.

Your plan participants will be able to make an appointment online, by phone or just drop in.

READ ABOUT NEW MANAGEMENT AT THE COALITION HEALTH CENTER, P. 1.

Since 1994, the Health Care Cost Management Corporation of Alaska, Inc. (HCCMCA) has been helping member health plans control health care costs by negotiating better pricing on health benefits and services than these same plans could achieve on their own. Current member health plans include 27 headquartered in Alaska and 19 headquartered in the Pacific Northwest.

Primary Care: Treatment for all kinds of conditions and illnesses, such as but not limited to: allergies, ear infections, strep throat, the flu, minor infections, rashes.

Urgent Care: CHC can handle minor injuries, such as but not limited to: stitching up cuts, bandaging sprains, setting broken bones, debris in eye and more.

Preventive Care: Make an appointment for routine exams and preventive tests, children's wellness visits, annual physicals, immunizations and lab tests.

Chronic Condition

Management: One-on-one coaching and care are available to

help manage chronic conditions such as diabetes, asthma or heart disease.

Pharmacy: Prescriptions written at the CHC for common generics and pre-packaged medications can be filled on-site.

Wellness Services: Health and lifestyle coaching are offered.
