

## ALASKA FRACTURE & ORTHOPEDIC CLINIC SIGNS PPO AGREEMENT WITH COALITION

he Alaska Fracture & Orthopedic Clinic (AFOC), a group that has a 50-year track record for "setting the standard for orthopedic care in Alaska," has joined the Pacific Health Coalition as a preferred provider (PPO).

"We see the Pacific Health Coalition as an organization that takes care of the people who build Alaska, who teach our kids and keep our towns running. Being in a PPO agreement with the Coalition just deepens our involvement with the community as a whole," said AFOC's CEO Brandon Ousley.

### **Care Designed for Alaskans**

AFOC has the expertise, experience and technology to take care of

every joint and bone in your body, from ankle to neck and everything in between. The clinic also offers sports medicine and treats orthopedic trauma resulting from accidents and workplace injuries.

The staff includes 13 physicians, 10 physician assistants, 10 therapists and two massage therapists, two athletic trainers and a nurse practitioner. "Our people are hardworking and caring. They are eager to welcome the new patients that the Coalition will allow us to reach," Ousley said.

AFOC has two locations, one in Anchorage and another in Eagle River. A third location will open in South Anchorage in October.

# Learn More About AFOC and Preferred Providers

Preferred provider agreements are just one way the Coalition works to provide high quality care at a lower cost for its members. Member plans may contract with one or more of these providers. "Because the annual price escalator for these contracts is fixed, the net price of services will remain controlled despite retail price increases," explained Coalition Executive Director, Fred Brown. "Member plans pay an access fee to the PHC based on utilization."

# **EVALUE8** FOR BETTER HEALTH PLAN PERFORMANCE

## 2018 Report Identifies Opportunities

The Washington Health Alliance's eValue8<sup>™</sup> tool helps provide insights into how well health plans in Washington State measure up in providing quality and value in three key areas in health care: 1) reducing overuse, 2) reducing underuse, and 3) reducing cost.

The eValue8<sup>TM</sup> 2018 Report, published in March 2019, identifies common areas of improvement for most or all of the health plans who participated. Here is a summary and examples of how the Coalition's services can help.

### Improve the patient/ member experience:

- 1. Help individuals effectively understand and use their benefits
- 2. Share easy-to-use information on provider quality and prices
- 3. Offer web-based, in-person, and telephone support
- 4. Improve access to care, self-management and member convenience through telehealth and web-based applications

Coalition services that can help include the <u>Coalition</u> <u>Health Centers</u> (in Anchorage and Fairbanks) and <u>Aetna's</u> <u>Teladoc</u> service.

### Effectively use health plan contracting and payment to drive higher value:

1. Increase use of value-based payments to providers, including shared risk

The eValue8<sup>TM</sup> 2018 Report, identifies common areas of improvement towards three goals for health care: 1) reducing overuse, 2) reducing underuse, and 3) reducing cost. The Coaltion services help health plans reach and exceed these goals every day.

- 2. Ensure robust and transparent measurement of health care value and align with state and nationally vetted measure sets
- 3. Use measurement results in feedback reporting to providers and to steer referrals to higher value providers
- 4. Manage specialty medications

Coalition services that can help include the <u>Coalition's PPO</u> <u>Agreements</u>, the <u>BridgeHealth</u> <u>Surgery Benefit</u> and <u>pharmacy</u> <u>benefit management services</u>.

### Improve outreach to engage members and improve health:

- 1. Use information like cancer screening and immunization rates, data on evidence-based care and self-management for chronic illness to close gaps in care
- 2. Identify members with depression, substance abuse, obesity, tobacco and nicotine use; broaden interventions to engage members in related programs

3. Improve network adequacy of and access to behavioral health services

Coalition services that can help include the <u>annual Health Fairs</u>, <u>Aetna's Teladoc for virtual</u> <u>behavioral health care</u>, and <u>disease management</u>.

# **Reduce potentially avoidable care and overuse:**

- 1. Ensure provider contracting includes performance expectations to reduce the rate of C-sections and avoidable hospital readmissions
- 2. Use health plan information and case management to help patients avoid re-hospitalization
- 3. Dissuade members from using the ER for care that could be delivered through primary or urgent care
- 4. Implement strategies and payment incentives to reduce use of procedures known to be overused and build overuse metrics into value-based contracting

Coalition services that can help include <u>dialysis cost containment</u>, <u>disease management</u>, <u>Aetna's</u> <u>nurse managers</u>, the <u>annual Health</u> <u>Fairs</u> and the <u>Coalition Health</u> <u>Centers</u>.

## NEW MEMBER SPOTLIGHT: UNITED EMPLOYEES BENEFIT TRUST

The Teamsters who are members of United Employees Benefit Trust drive the roads and work in warehouses all over Washington State. They are joined by members of the OPIEU and AFSCME to form a core group of 2,200 members and 5,500 covered lives.

"Those of us who work in the administrative office are proud Teamsters, as well," said Diana Clark, administrative manager. Since starting as a claims processor 25 years ago, she now oversees daily operations in the Trust's Tacoma headquarters and works closely with the board of trustees to ensure the Trust continues to evolve its services.



That evolution includes joining the Pacific Health Coalition early in 2019. "We were looking to better manage our dialysis benefits, and our benefit consultant suggested we take a look at the Coalition," Clark said.

The group is now accessing Renalogic's services through the Coalition's agreement with the dialysis cost containment provider. "We're also promoting the Health Fairs to our membership. Two of our trustees will be there to help out in Tacoma and Pasco and I look forward to going to the fair in Kent," Clark said.

## NEW AETNA PLAN LEVERAGES THE POWER OF THE COALITION FOR THE LARGER COMMUNITY

Since 1994, the Pacific Health Coalition has been providing member access to quality health care while controlling costs. Now, in partnership with Aetna, the Coalition is reaching out to the larger community to help ensure that more people can receive quality care at a lower cost.

The Anchorage Mat-Su Community Plan gives small employers access to the lower preferred provider organization rates negotiated by the Coalition and Aetna. "This really is a perfect extension of our belief in the importance of quality, affordable health care for everyone," said Fred Brown, the Coalition's executive director. "And it is another example of how strength in numbers can produce savings and performance opportunities for all of our members."

The Community Plan grew out of the recognition that small employers have been unable to negotiate on a level playing field in today's health care marketplace. It also addresses the appeals of some legislators to provide our services to the larger community.

"Given that the Coalition's contracts with Aetna were already in place, it was relatively straightforward to create a Community Plan that covers many of the same facilities and providers," said Greg Haley, Aetna's vice president for sales & service, Northwest Middle Market. That list includes Alaska Regional Hospital, Mat-Su Medical Center, and the Surgery Center of Anchorage, among others. The plan covers specialists in cardiology, orthopedics, and gastroenterology, to name just a few.

# The Community Plan and the Alaska HCA

As a viable alternative to the proposed state-run Health Care Authority in Alaska, Brown noted that the new Anchorage Mat-Su Community Plan "allows us to make the argument that there are alternatives to a legislatively imposed solution. With this plan we are reaching out to small employer groups for the benefit of the families they cover."
